SUBJECT

: FY 2024 Budget Implementation of FY 2023 General Wage Adjustment

Funds to General Fund Programs

The FY 2024 Budget Resolution CS-78-23 appropriated \$5,478,564 from the Personnel Lapse Savings Funds to General Fund programs for use in the FY 2024 budget. The Budget Resolution at Section Three, Directives, E., reads as follows:

"E. The Department of Personnel Management, the Office of Management and Budget (OMB), and the Office of the Controller, shall consult with the Department of Justice to develop an internal administrative process for programs to administratively budget the funds appropriated in this FY 2024 Comprehensive Budget from the Personnel Lapse Savings Account for FY 2024 costs related to the FY 2023 General Wage Adjustment. Such appropriation may be budgeted by programs for operating expenses and personnel expenses. The internal process shall be reported to the Budget and Finance Committee and published on the OMB website to provide notice to the programs, by no later than October 15, 2023."

Accordingly, the attached report shows the actual costs for the FY 2023 GWA amounts for each General Fund Business Unit. Each designated program should prepare Budget Forms 1, 4, and 3 and 5 (if personnel) in the listed amounts and submit to OMB for review. When finalized, OMB will add the funds to each FY 2024 General Fund program budget. These funds will relieve the extra cost for absorbing the FY 2023 5% GWA into the FY 2024 budgets.



Please submit the completed budgets to OMB no later than November 3, 2023. The sooner the budgets are submitted then the funds can be entered into FMIS and made available for use.
